regarding credits and exams organisation organisation in Faculty of Philology

Pursuant to the Rector's Regulation no. 58/2020 on specific principles of credits and exams organisation outside of the university, using IT technology, I hereby introduce the following regulations in Faculty of Philology during the summer examination session of academic year 2019/2020:

- 1. Verification of learning effects, within the credit or exam procedures in the defined study courses shall be possible outside of Opole University, with the use of IT technologies, ensuring a procedure control and recording.
- 2. Detailed instructions on credits and exams organisation via IT technologies are included in §4 of the Rector's Regulation no. 58/2020.
- 3. Students, in cooperation with the teachers responsible for credit or exam procedures, shall agree on the form of learning effects verification.

- 4. On behalf of students of a given year, the year leader shall fill in the table presented in Annex 1 to the announcement, and submit it to the Coordinator.
- 5. The Coordinator, in cooperation with other coordinators in the Faculty, shall check the possibility of carrying out credit or exam proceedings, safe to both students and teachers, pursuant to the recommendations of the Opole University Chancellor.
- 6. Having established the possibility of carrying out credit or exam proceedings in a safe manner, the Coordinator shall inform a group leader and the relevant teacher.
- 7. Credits and exams schedule shall be made available in the Faculty web site on 10 June 2020.
